COURSE DESCRIPTION:

This course is a study of the etiology of alcohol and drug abuse, various types of addictive substances, physical, mental, and social implications, programs in rehabilitation, and preventive education.

COURSE COMPETENCIES:

Upon completion of HUS 208---Alcohol and Drug Abuse, students should be able to:

Module 1: Personal Attitudes and Biases toward Addicted Persons

1. Identify personal attitudes, values, biases, and stereotypes that may be overtly or covertly present and may influence one's ability to develop a positive helping relationship.
2. Identify strategies to address personal helper issues that will promote positive personal growth and a deeper understanding of the nature of addiction.

Module 2: Knowledge Base and Skill Sets Necessary to Work with Clients

1. Discuss the historical perspective of the present-day drug-oriented society and the impact on personal drug behavior.
2. Interpret the current scientific research as it relates to the impact of drugs on the mental, emotional and physical well-being of those addicted.
3. Explain the medical model approach to addiction.
4. Explain the various psychosocial models of substance abuse.
5. Identify a variety of substances that are frequently abused.
6. Identify precipitating factors that make one more likely to abuse substances.
7. Identify a variety of substance abuse agencies both locally as well as statewide.
8. Identify a variety of intervention strategies utilized in treating those addicted.
9. Develop evaluative skills necessary to support the intervention strategies necessary to treat clients.
10. Examine the current political landscape as it relates to policies that address laws and intervention programs designed specifically for substance abuse issues.

Module 3: Professional Development

1. Participate in a workshop or seminar that specifically addresses substance abuse issues.
2. Demonstrate professional behavior to include professional attire when appropriate.
3. Demonstrate professional behavior to include time management skills, team building, and conflict management and stress management skills.
4. Select appropriate work samples for developmental portfolio.

MINIMAL STANDARDS:

A minimal grade of C is required in this course.

COURSE REQUIREMENTS:
