COURSE DESCRIPTION:

This course includes production experiences at television production locations.

COURSE COMPETENCIES:

Upon successful completion of this course, the student should be competent to perform the following tasks:

- Demonstrate basic non-technical job skills
- Apply technical skills from previous and concurrent courses.

MINIMAL STANDARDS:

Given a weekly production schedule and individual assignments for each week of the quarter, each student will perform to standards and guidelines cooperatively generated by the Teleproduction Department Manager and the participating agency (in particular, WNSC-TV). These standards would typically (see instructor for details) include:

- contacting the specified supervisor at least 24 hours in advance of stated production activity, confirming the assignment
- reporting for assignments no later than the specified time
- performing as requested, within the limits of reasonably expected (criteria determined by the instructor) skills
- keeping a written record of each production assignment as specified

Given weekly class projects, the student will actively participate in all production activities, to standards and guidelines provided by the instructor.

COURSE REQUIREMENTS:

Students are responsible for demonstrating acceptable performance of competencies. Supporting this goal are the following requirements:

ATTENDANCE

Students will be bound by the policies stated in the York Technical College Student Handbook. Students must attend 80% of the hours assigned the class for a semester to receive credit for the course.

ACADEMIC HONESTY

Students will participate in an average of six hours of production activity per week over the course of the quarter. This will consist of a combination of class projects, and individually assigned production assistance with departmentally approved production facilities (typically, WNSC-TV).

As in the workplace, the student should call the instructor (or designee) in advance of an absence or tardy, if at all possible.

Completing assignments as specified.

EVALUATION STRATEGIES/GRADING:

Student proficiency consists of both knowledge, application, and behavior. Evaluation is based on specific performance. The grading scale will be consistent with the York Technical College standards for such a course.

CO-REQUISITES:

Producing and Directing (RTV-107).
